## **2021 DISCIPLINARY ACTIONS**

### **Case #2021-003BR**

**Respondent: Norred & Associates**

**Date: May 13, 2021**

**Disposition:** Respondent violated Ala. Code 1975 § 34-27C-7(a) by failing to have security guards licensed within thirty (30) days of their initial employment with the company; and Ala. Code § 34-27C-4(a) by allowing their license number 00147 to expire on September 30, 2020 and said license was not renewed. Respondent entered into a consent agreement with the Board regarding the alleged violations. Pursuant to the consent agreement, Respondent was assessed a fine of one thousand dollars (\$1,000.00); will have all employees registered and licensed within thirty (30) days; and placed on probation for one (1) year. The probation period is May 13, 2021 through May 13, 2022.

### **Case #2021-005BR**

**Respondent: Cordarius “Corey” Turney dba Elite Patrol Services**

**Date: December 30, 2020**

**Disposition:** Respondent violated Ala. Admin. Code r. 832-X-1-.04; 832-X-1-.11; Ala. Code 1975 §§ 34-27C-4; and 34-27C-7 by allowing their security company license to expire on September 30, 2019, and operating without a company license. Respondent provided security services in Alabama as an unlicensed security guard (license expired July 30, 2020). Respondent also failed to cooperate with an inspection that occurred in the month of December 2020. The Board issued a Cease and Desist Notice to the Respondent.

### **Case #2021-007**

**Respondent: Cordarius “Corey” Turney dba Elite Patrol Services**

**Date: October 8, 2021**

**Disposition:** Respondent violated Ala. Code 1975 § 34-27C-4(a) by providing security services in Alabama without proper licensure issued by the Board; and Ala. Code 1975 § 34-27C-7(a) by failing to have security guard license within thirty (30) days of initial employment with the company. Respondent entered into a consent agreement with the Board regarding the alleged violations. Pursuant to the consent agreement, Respondent was assessed a fine of one thousand (\$1,000.00) dollars; agree to submit his application for security guard licensure with the Board; and placed on probation for one (1) year. The probation period is August 12, 2021 through August 12, 2022.

**Case #2021-013**

**Respondent: Ashton Kramer**

**Date: August 12, 2021**

**Disposition:** Respondent voluntarily surrendered his Alabama Security Regulatory Board License Number 36532 issued by the Board during the investigation of a complaint received by the Board.

**Case #2021-014**

**Respondent: Don Gomien dba Don Gomien & Associates**

**Date: August 16, 2022**

**Disposition:** Respondent violated Ala. Code 1975 § 34-27C-12(a)(4) (Prohibited activities), it is unlawful for any person or entity to knowingly make or provide false statements to the board or omit any document or information required to be filed with the board; Ala. Code 1975 § 34-27C-12(a)(5) (Prohibited activities), it is unlawful for any person or entity to falsely represent a person to be a holder of a license or certification card; and Ala. Code 1975 § 34-27C-12(b)(1) (Prohibited activities), it is unlawful for any person or entity to fail to comply with or violate this chapter and the rules of the board. Respondent entered into a consent agreement with the Board regarding the alleged violations. Pursuant to the consent agreement, Respondent was assessed a fine of five thousand dollars (\$5,000.00); will be suspended and that suspension will be held in abeyance while Respondent serves a probation period of one (1) year. The probation period is August 16, 2022 through August 16, 2023. Respondent shall comply with all statutes and regulations of the Board and submit inspection reports pursuant to any request for inspection by the Board.
